## Hamilton-Jacobi theory for inverse problems

**Abstract**: this talk I will show how the Hamilton-Jacobi theory can be used for constructing regularizations and error estimates for inverse problems for PDE, formulated by optimal control. I will give examples determining the reaction functions and the noise in stochastic PDE for phase-transitions, optimal design of electrical conductors and calibration in mathematical finance.
